I understand that ...

- Computers and other information technology resources at Parkhurst State School are intended for use in learning
- Every student is given an account on the school's computer network and this is private to me
- No other student may interfere with my account and I may not interfere with theirs
- The Internet can connect me to much useful information stored on computers around the world
- The Technology Administrator in my school can track everything I do and will report what I do to the Principal, if necessary

While I have access to the Internet, I **agree that . . .**

1. I will take care of information technology resources
2. I will not eat or drink near any school owned equipment
3. I will use it only for educational purposes
4. I will attempt not to break copyright (eg; illegally copying information from the Internet or a CD Rom and passing it off as mine).
5. I will not print or download without a teacher's permission.
6. I will not change anything on a computer's operating system (eg; screen savers, shortcuts, etc) unless that skill is a part of the lesson I am being taught.
7. I will not do unnecessary printing.
8. I will not attempt to upload or create computer viruses or be involved with other forms of electronic vandalism.
9. I will report any security problems to the Technology Administrator.
10. While I have access to the Internet I will use it for educational purposes and will not look for anything that is illegal, dangerous or offensive.
11. If I accidentally come across something that is illegal, dangerous or offensive, I will ...
 - clear any offensive pictures or information from my screen and immediately
 - quietly, inform my teacher
12. I will not reveal home addresses or phone numbers, mine or anyone else's while using the Internet
13. I will not use the Internet to annoy or offend anyone else
14. I will only use a USB memory stick to transfer data to and from home
15. I will not give anyone my username or password

I understand that if the school decides I have broken these rules, appropriate action will be taken. This may include loss of my Internet access for some time.
